

## GESTAMP BIOMASS GROUP WEB PRIVACY POLICY

### Use of Cookies

Gestamp Biomass uses cookie technology to enable:

## Personal Information

The personal information we collect through the website, which we may use to identify you or contact you are:

- Telephone number;
- Address;

You may also choose to allow Gestamp Biomass Group to customize your visits to the website, in which case we will request certain personal information so that your visits can be more useful. When this information is combined with the non-personal information we collect through cookies, we will be able to track your visit to the website and from Gestamp Biomass Group you will be able to customise your access to the website, for example, by informing you about new functions that may be of interest. It is the responsibility of the data subject to provide accurate and up-to-date personal information. Gestamp Biomass Group will not be able, nor will it be responsible for any problem or liability that may arise if the data subject does not provide accurate, truthful or complete information or if it does not update the information provided.

## Storage and use of personal information

Gestamp Biomass may store and use personal information collected through the website for the following reasons:

- Respond to requests from the data subject;
- Personalize the access to the website, for example, by informing about new functions that may be of interest to the data subject;
- Develop records for internal business use, including records of personal information;
- Analytical purposes and research, development and improvement of programs, products, services and content;
- Remove personal identifiers (name, email, social security number, etc.). In this case, you would no longer be identified as a unique individual. Once we have de-identified the information, it is non-personal information and we may treat it as other non-personal information;
- Comply with the privacy policy and other rules regarding the use of the website;
- Protect the rights or property of Gestamp Biomass Group;
- Protecting someone's health, safety or welfare and/or;
- Comply with any law or regulation, court order or other legal process.

## Sharing personal information with third parties

Gestamp Biomass Group will not share the personal information of interested parties collected on the website with an unrelated third party without your permission.

In the ordinary course of business, if you give permission, Gestamp Biomass Group will share certain personal information with the companies we contract to perform services or functions on our behalf. In cases where personal information is shared with a third party, it will not be authorized to maintain, disclose or use the information of the data subject with others, except for the purpose of providing the services that from Gestamp Biomass Group are required.

The personal information provided by the data subject will not be sold, exchanged or published, except in conjunction with a sale, merger, dissolution or corporate acquisition. The data subject shall at all times have the right of access, rectification and opposition to the use of personal data.

Gestamp Biomass Group may be legally required to disclose your personal information in response to a court order, search warrant, law, regulation, cooperation with law enforcement authorities in investigating and prosecuting individuals who have visited the website or who violate our rules or behave in a manner that is harmful to other visitors (or illegal).
